

GRANDEUR PEAK FUNDS TAX YEAR 2023 FOREIGN SOURCE INCOME

The Grandeur Peak Funds listed below have elected to pass through to shareholders the foreign taxes paid on income earned from foreign investments. These foreign taxes are reported in Box 7 of Form 1099-DIV. As a shareholder of one of these funds, you may be able to claim a tax credit or an itemized deduction on your federal tax return for the amount of tax paid to foreign countries. You should consult your tax advisor to assist you in determining your eligibility to claim either the foreign tax credit or foreign tax deduction and for help in choosing which option is in your best interest.

To calculate your foreign source income, multiply the amount in Box 1a of your Form 1099-DIV by the "Foreign Source Income Percentage" in the table below. To calculate your foreign source qualified dividends, multiply the amount in Box 1a of your Form 1099-DIV by the "Qualified Foreign Dividend Income" in the table below.
